

TERMS

- No spamming is allowed. You may only send a referral email (or any copy that contains your affiliate link) to people you know or people on your opt-in list. If you use a third-party email list, the list must be 100% opt-in! Any unsolicited sending of your link (for example, sending your link in a unsolicited mass email, spam) will result in immediate cancellation and forfeit of all commissions you have earned. Also, your affiliate status will be terminated.
- Referrals must be NEW to MBE INTERNATIONAL LLC sites. If you refer someone who has already been referred by another affiliate, or is an existing customer of MBE International LLC, you will not receive credit if they purchase.
- Affiliates may not promote any of the MBE INTERNATIONAL LLC banners or links on sites displaying child pornography, bestiality, hate sites, or sites displaying any other kind of illegal material. MBE INTERNATIONAL LLC reserves the right to be the final arbitrator of what constitutes child pornography, bestiality, or a hate site.
